4. ROAD 92 PROJECT – DIRECTOR OF PUBLIC WORKS

(a) Steve Oliver, Acting Director of Public Works and the Township’s consulting engineer, Alan Johnston of Driven Engineering Inc., present plans for the reconstruction of Road 92.

Mr. Johnston advises that construction will take approximately two weeks and will see vertical improvements carried out primarily on the hill in the vicinity of the cemetery. He notes the road will not be open for traffic and limited access to properties will be available.

In response to a question, Mr. Johnston advises the Township will do its best to allow ditches to remain flat enough for residents to cut the grass. Working within a 66’ right-of-way with side hills will make this difficult, however, every effort will be made.


