BY-LAW NO. 43-03

**A BY-LAW TO AUTHORIZE THE EXECUTION OF AN
AGREEMENT BETWEEN THE CORPORATION OF THE
TOWNSHIP OF ZORRA AND THE CORPORATION OF
THE TOWNSHIP OF SOUTH-WEST OXFORD**

WHEREAS pursuant to Section 2(5)(a) & (b) of the Fire Prevention and Protection Act, S.O. 1997, Chapter 4, states that a municipality may, under such conditions as may be specified in the agreement, enter into an agreement to provide or receive such fire protection services as may be specified in the agreement to lands or premises that are situated outside the territorial limits of the municipality;

AND WHEREAS the Township of Zorra and the Township of South-West Oxford are desirous to enter into an agreement for the use of certain fire fighting equipment of the Township of South-West Oxford within a certain area of the Township of Zorra;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ZORRA ENACTS AS FOLLOWS:

1. That the Mayor and Clerk Administrator are hereby authorized and directed to execute an agreement in duplicate and affix the Corporate seal thereto with the Township of South-West Oxford.
2. That a copy of the said agreement shall be annexed to and form part of this by-law.

BETWEEN:

THE CORPORATION OF THE MUNICIPALITY OF ZORRA,
OF THE FIRST PART;

-and-

THE CORPORATION OF THE TOWNSHIP OF SOUTH-WEST
OXFORD,
OF THE SECOND PART;

WHEREAS the Township of South-West Oxford has fire fighting equipment and firefighters stationed in Beachville, at the Beachville Fire Hall;

AND WHEREAS the Township of Zorra is desirous of obtaining the services of said fire fighting equipment and firefighters of the Township of South-West Oxford to provide fire protection service for a particular area in the Township of Zorra adjacent to the village of Beachville, subject to such terms and conditions as are hereinafter set out;

NOW THEREFORE the parties hereto mutually agree as follows:

1. The Beachville Fire Hall shall respond to emergencies occurring in the area indicated in attached Schedule "A" when:
 - a. Automatically dispatched to emergencies which may involve rescue operations;
 - b. Automatically dispatched to emergencies which may constitute a major threat to life and property or;
 - c. Requested by the Fire Chief, or Officer of the Township of Zorra Fire Department.
2. The Beachville Fire Hall shall supply sufficient fire apparatus (maximum three vehicles) and fire fighters where there is a need to provide immediate rescue and property protection.
3. The Township of Zorra shall not be liable or responsible for the firefighter of the Township of South-West Oxford in the event of injury, or to the Township of South-West Oxford for any damages resulting to the fire fighting equipment owned by the Township of South-West Oxford while responding to, or attending at, or returning from a call within the said Township of Zorra.
4. The Township of Zorra agrees to pay the Township of South-West Oxford the amount per automatic aid response as described in Schedule "B".
5. This agreement shall continue in force until altered, amended or rescinded by giving ninety (90) days notice in writing of such alteration, amendment or rescinding of this agreement by either party hereto to the other.
6. The Township of Zorra agrees to replace materials used during emergency situations by the Beachville Fire Hall when they are engaged in an automatic aid response in the Township of Zorra. These materials include, but are not limited to Class A and B Foams, extinguisher refills, and spill absorbents.

SCHEDULE "B"

1. **“The Township of Zorra will pay the Township of South-West Oxford for Automatic Aid response from the Beachville Fire Hall. The amount of such payment shall be \$300.00 per vehicle (to a maximum of three vehicles), for the first hour on scene. It is understood that the normal response will be with three vehicles. For each additional hour (or portion thereof), the rate of \$300.00 shall continue.**

In addition, the Township of Zorra shall reimburse the Township of South-West Oxford for actual costs incurred fir Fire-fighters time to complete reasonable clean-up of vehicles and equipment related to each Automatic Aid response, where such clean-up extends beyond the hour(s) on-scene.”
