Please follow Southwestern Public Health and Ontario Health for your opportunity to get vaccinated and help your community.

As I write this on May 21 there are 8 active COVID-19 cases in Zorra, 73 in Oxford, and 102 in Southwestern Public Health as a whole, and we are in a Provincially ordered province wide State of Emergency and Stay at Home Order. While our local numbers are relatively good, that's BECAUSE of the controls in place and increased vaccination rates. Please continue to #DoYourPart to help prevent the spread of COVID-19, to keep your community healthy, and businesses and services open:

- Stay home if you are sick
- Practice physical distancing by staying at least 2 metres apart
- Wear a face covering
- Wash your hands
- Do not gather with people outside your household
- And do your part and vaccinate!

Zorra Staff are diligently following the Provincial rules around the re-opening plan, please be patient with them as they find out about the changes in the same press conference that you do. I will continue to lobby both SWPH and the Province for a science and evidence based local plan for re-opening.

Last year Zorra Council passed a resolution in support of a School Retention Plan recommended by the Zorra Local School Committee. The plan has now been endorsed by:

- Zorra Township Council
- Oxford County Council
- Thames-Centre Council
- Middlesex County Council
- Elgin County Council
- TVDSB

My next step is to get London City Council to endorse it. Then it would be all municipalities in the TVDSB. Then we can start to see some real change regionally for a better relationship between our municipalities and school boards on behalf of the communities we represent, and lobby the Province for policy changes based on this.
