#### RECOMMENDATION:

#### **BACKGROUND & COMMENTS:**

The 2024 budget process has begun informally with Department Heads in July/August. This is representative of the annual budget process with the Director of Finance holding individual meetings with senior management regarding budgetary needs followed by an overall review of the joint budget document with all senior managers. Throughout the process, Township priorities are examined, and as necessary changes are made/alternatives examined and projects are in line with the strategic priorities of Council.

Council passed at its September 7, 2022, regular meeting, a more streamlined, departmental summary approach to the annual budget process. Council will receive a digital copy of the Township's comprehensive budget document by November 1, 2023, Council meeting. The package will contain an overall summary of the budget highlights, a summary of departmental activities, projects, goals, and strategies for both capital and operating budgets; including 10-year capital plans and line-by-line detail.

For Council's information; Table 1 provides the historical increases of the annual tax levy, the municipal tax rate of the Township, and the overall tax rate for all levels of government.
