## **BACKGROUND & COMMENTS:**

The 2026 budget process began informally with Departments in August. As part of the annual budget process, individual meetings are being held with the Manager of Finance, Deputy Treasurer/Financial Analyst and Managers/Directors regarding budgetary needs followed by an overall review of the compiled budget document with all senior staff. Throughout the process, Township priorities are examined, and, as necessary, changes are made/alternatives examined. Projects are in line with the strategic priorities of Council.

Council will receive a digital copy of the Township's comprehensive budget document for the November 5, 2025, Council meeting. The package will contain an overall summary of the budget highlights, a summary of departmental activities, projects, goals, and strategies for both capital and operating budgets; including 10-year capital plans and line-by-line detail.

For Council's information; Table 1 provides the historical increases of the annual tax levy, the municipal tax rate of the Township, and the overall tax rate for all levels of government for the past 8 years.
