POSITION TITLE:

Crossing Guard.

STATUS:

Seasonal during school season, part-time, Monday to Friday, one (1) to two (2) hours per day. The hourly rate for this position is \$19.00/shift or \$38.00/day.

DESCRIPTION:

This job posting is for a current vacancy. We are searching for a responsible and community-minded individual to join our team. As the Crossing Guard, reporting to the Recreation Programs & Services Coordinator, you are responsible for the safe passage of pedestrians (especially students/children) at the crosswalk on Dundas Street in Thamesford, and stopping traffic in accordance with the Ontario Highway Traffic Act, the Occupational Health and Safety Act, and the Township of Zorra policies and guidelines. Duties include:

- Direct and guide pedestrians (including students and youth) across streets during the school
 year, stopping traffic as required, in accordance with the Ontario Highway Traffic Act, the
 Occupational Health & Safety Act and Corporation guidelines on designated roadways
- Direct traffic movement using signs and hand signals
- Relay information in a clear and concise manner while handling potentially stressful situations
- Communicate crossing rules and other information to students and adults
- Be courteous to students and other pedestrians using the crosswalk
- Note any unusual conditions at your crosswalk before students arrive (Buildup of ice and snow, traffic lights out, signs blocking vision, construction, etc.).
